RELEASE AND WAIVER OF LIABILITY

The undersigned players and parents understand that voluntarily playing or participating (including, but not limited to organized practice activities, conditioning activities, competition and scrimmages) in the sport of basketball (hereinafter “this sport”) may be a potentially dangerous activity involving risk of injury. The undersigned understands that in this sport, an athletic participant can be seriously injured.

The undersigned are aware that the dangers and risks of voluntarily playing or participating in this sport include, but are not limited to, falls, contact or collisions with other participants, equipment and facilities, and the effects of weather, including high heat and humidity (facilities may not be air conditioned). The undersigned understands that participant may incur a serious injury, including paralysis or death, as a result of the dangers and risks associated with participating in this sport. The undersigned certifies, each by signature below, that participant is in good health and physical condition and sufficiently able to voluntarily play or participate in this sport.

In consideration of permission granted to the undersigned, and knowing and having been informed of the potential dangers and risks associated with voluntarily participating in this sport, to use the facilities at Juanita High School for the purpose a basketball tournament, each undersigned hereby agrees on behalf of myself, my family, my children and heirs, executors, administrators, guardians and agents to assume all such risks and, further, to waive, release, discharge and hold harmless, all Select Coaches, players, Lake Washington School District, and Juanita Basketball Association and their respective employees, agents, representatives, physicians, athletic trainers, managers and volunteers from any and all liability, actions, causes of actions, claims or demands for personal injury, death or property damage of any kind or nature, and any other claims whatsoever arising out of, or in any way connected with participant’s voluntarily participating in this sport, whether caused by negligence of coach(es), players, Lake Washington School District, and Juanita Basketball Association, and their respective employees, agents, representatives, physicians, athletics trainers, team managers and volunteers or otherwise, as a result of participant’s use of the facilities at Juanita High School. This Release and Waiver extends to all claims of every kind or nature, whatsoever, foreseen or unforeseen, known or unknown. Each undersigned hereby agrees that the terms hereof shall serve as an assumption of risk, release and waiver for myself, my family, my children and heirs, executors, administrators, guardians and agents or anyone else who might assert a claim on my behalf.

The undersigned does hereby consent for any coach(es) and staff working any organized participation activities to arrange first aid or medical treatment for participant, according to their best judgment, in the event participant suffers an injury or illness while participating in this sport at facilities owned and operated by the Lake Washington School District.
